






1 Log in to the **eMPF** Mobile App.







**3** Read the instructions and tap **Start Enrolment**.

**a1** Download the "iAM Smart" mobile app to your smartphone and register as an "iAM Smart" user.



**a2** Follow the instructions and perform the subsequent steps as indicated on your "iAM Smart" mobile app.

10. It is the responsibility of TFC account holder to keep track of the total amount of TFC made in a year of assessment for completion and filing of tax return. It should be noted that the maximum amount of deductions allowable under section 10 and 10A under personal assessment in a year of assessment under the Inland Revenue Ordinance (Cap. 112) is an aggregate limit for both TFC and qualifying annuity premiums (other than for TFC only).

11. Please note that only the amount of TFC made by or in respect of the member during the assessment year is tax deductible but not the amount of TFC transferred in from other TFC accounts.
