Preface

The **eMPF Platform** is a centralized and integrated electronic platform that aims to standardize, streamline and automate the administration processes of different MPF schemes, with a view to enhancing operational efficiency, reducing administration costs and improving user experience in managing their MPF account(s).

This user guide provides step-by-step instructions on how a scheme member registers for **eMPF™** on the **eMPF Web Portal**. Upon successful registration, users can access the electronic services offered by the **eMPF Platform**, including MPF account management and submission of MPF scheme instructions. All screenshots are for illustration purposes only. The actual design of the portal interface may be different.






1 Visit eMPF Website www.empf.org.hk

2 Click **Register** on the top right-hand corner of the menu bar.


3 Select **"Scheme Member"**.




4 Read the notice and tap **Continue**.



5 Read the instructions and click **Register**.






6 Please verify with **“iAM Smart”**.

1 Download the **“iAM Smart”** mobile app to your smartphone and register as an **“iAM Smart”** user.



2 Log in to **“iAM Smart”** and tap **QR code scanner**. Scan the QR code shown on the webpage and perform the subsequent steps as indicated on your **“iAM Smart”** mobile app.

7 After you complete the authentication process via “iAM Smart”, some of your personal information will be pre-filled automatically. Please review if the pre-filled information is correct and fill in the remaining information including Contact Information, Address and more. Then, click **Next**.



Tips: Please remember to verify your **email address** and/or **mobile phone number** by clicking **Verify** next to these 2 fields. You will receive a one-time passcode through email and/or SMS respectively, simply enter the verification code to finish the verification.
